The team uses public art and murals to engage their community and to share important stories. In the summer of 2020, this team of talented young artists created the "Wall of Gratitude," a series of portraits of community members who they wanted to say thank you to for their important work during the pandemic. The folks featured in the artwork are everyday people that the team considers local (s)heroes. When their community needed them most, these (s)heroes continued their important work and service on the frontlines and at a grassroots level throughout the pandemic. The "Wall of Gratitude" (funded in part by The Boston Foundation's Shout Syndicate grant program), was created as part of the "City All" initiative to increase the representation of the Lynn community inside City Hall using the arts. The project began in the summer of 2020 and was intended for installation in the fall of 2020.
