

CONSTABLES

Constable applications are available in the Mayor's office. The Mayor appoints the Constables and after they are approved by the City Council, the applications and approvals are sent to our office. The City Clerk 's office maintains the records and issues the Constable his/her certified appointment card.

Please refer to Massachusetts General Law Chapter 41 for up to date information on Constable appointment and MGL Chapter 268A Section 23 for Standards of Conduct.

Steps to complete Appointment :

1. Type out Appointment Card and Swear in Constable
2. Collect fee: \$50.00 per each year appointed
3. Copy for our database
4. File approval w/app in Constable file

as follows:

A fee of Twenty-Five (\$25.00) Dollars shall be charged for the appli-
cations for the appointment of Constables and other Servers of Civil
Process in the City of Lynn.

SECTION 2. All Ordinances or parts of ordinances inconsistent herewith
are hereby repealed.

SECTION 3. This ordinance shall take effect thirty-one (31) days after
its final approval as adopted and advertised.
