**/Ordered that the City of Lynn will accept the ownership and responsibility for all required maintenance for the Traffic Signals to be installed at the intersection of Boston Street and Ford Street by Tropic Star Development which was a condition of the issuance of a Special Permit to permit for a pharmacy at 47, 55, and 65 Boston**

**Street. Further ordered that the City of Lynn will assume all required maintenance of improvements to existing Traffic Signals located at: Boston Street at Washington Street, Boston Street at Franklin Street, Western Avenue at Washington Street and Western Avenue at Franklin Street. Said acceptance is specifically subject to the approval by the Inspectional Services Director that said installation and repairs comply with all applicable rules and regulations relating to traffic signals and that the installation and repairs have been undertaken in a good workmanlike manner.**
