Food-Related Fees**

**Food establishments are classified based upon risk. Commissary kitchens, produce vendors, hand carts, bakeries, package stores, residential kitchens and canteen food trucks shall be permitted at a rate consistent with their risk-level and food permit type.

New Dining Establishment	\$300 up to 100 seats, \$500 >100 seats
New Retail Establishment	\$300 up to 10,000 sf., \$500 > 10,000 sf
NOTES:	
**Annual Permit Applications shall be due <u>at least 30 days</u> prior to expiration of existing permit. Permits received fewer than 30 days before expiration shall be assessed a late fee.	
**Inspections shall be scheduled 7-10 days after filing of application for certificate of inspection.	

¹Applicants must apply for a milk or frozen dessert manufacturers license but permission will be noted on the food permit and no fee will be assessed.
