COUNCIL ORDERS, RECOMMENDATIONS & REQUESTS

Council Orders:

- 1. Councilor Ashraf:** **Recommends that the Lynn School Department look into installing metal detectors in all Middle and High Schools.**

- 2. Councilor Barbuzzi:** **Recommends that the City of Lynn look into apply for Renewal Energy grants and “Green Grants” for all public property buildings in the City of Lynn.**

- 3. Councilor Bozarjian:** **Recommends that the pedestrian overpass on the Lynnway be cleaned up and a brick front be added to better represent the city as drivers go by.**

- 4. Councilor Chambers:** **Recommends that the Lynn School Department look into the feasibility of opening the school gyms after school for the students. (FORD)**

- 5. Councilor Chaykler:** **Recommends that the city look into designating an area within the Waterfront Master Plan for a bike route. (CAHILL)**

- 6. Councilor DiFillipo:** **Recommends that all Lynn School Teachers are**

mandated to comply with a professional dress code requiring all male teachers to wear ties and all female teachers to wear professional business attire.

- 7. Councilor Gill:** **Recommends the City explore hosting free summer concerts at Manning Field for the youth of the city. (TRAHANT)**
- 8. Councilor Idusuyi:** **Ordered that the Lynn City Council amend the existing Ordinance prohibiting marijuana consumption upon City of Lynn property to make the parents of a minor offender jointly and severally liable for all applicable fines. (MACKIN)**
- 9. Councilor Ladderbush:** **Recommends that the Lynn City Council send a letter to the State Delegation as being on record in favor of the creation of casinos in Massachusetts. (KENNEDY).**
- 10. Councilor Stevens:** **Recommends the DPW Director be requested to look into the feasibility of funding the Parks and Recreation budget for a “City-Wide Olympics” event for ages 6-18 years, to be held in late August. Olympics to include basketball tournament, baseball, softball, and relay races. (CYR)**
- 11. Councilor Womack:** **Recommends that the Mayor be requested to establish a Youth Violence Task Force that would include students, parents, community leaders, school department personnel, and the Lynn Police Department to address the youth violence in the City of Lynn. (CAPANO)**
