IN THE YEAR TWO THOUSAND AND TWELVE AN ORDINANCE AMENDING THE ZONE ORDINANCE OF THE CITY OF LYNN

Be it Ordained by the City Council and by the authority of the same as follows, to wit:-

SECTION 1:00

Adding the definition of "MEDICAL MARIJUANA TREATMENT CENTER: to Section 5; CLASSIFICATION OF USES; Section 5.4 "BUSINESS USES" as follows:

5.4.38 Medical Marijuana Treatment Center: An establishment that acquires, cultivates, possesses, processes (including development of related products such as food, tinctures, aerosols, oils or ointments), transfers, transports, sells, distributes, dispenses or administers marijuana or products containing marijuana and/or related supplies for ostensibly medical purposes.

SECTION 2:00

Amending the Use Table, Section 4, by adding "Medical Marijuana Treatment Center" after 4.26 "Massage Parlor" to the list of uses as follows:

SECTION 3:00

Adding Footnote (15) following the Use Table, Section 4, as follows:

(15) No Medical Marijuana Treatment Center shall be located with 1000 feet of a public school, private school, parochial school, city or Commonwealth of Massachusetts approved Charter School, a public or private accredited preschool, an accredited headstart facility, elementary, vocational or secondary school and city and/or state public park or playground or a residential dwelling unit which is located within the City of Lynn boundaries. The distance between any school, residential dwelling unit, park or playground, as herein described, and a proposed Medical Marijuana Treatment Center will be determined by a straight line from the boundary of the school, residence and/or park/playground and the boundary to the Medical Marijuana Treatment Center.
