Public Notice is hereby given of the Waterways Application by South Harbor Associates, LLC to demolish an existing commercial building (Lynn Mart) and construct a 550-unit multi-family residential development with restaurant/retail space and associated parking, connecting walkways, and open space partially located on filled tidelands of Lynn Harbor at 800-810 Lynnway in Lynn, Essex County. The proposed project has been determined to be Nonwater-Dependent.

The Public Hearing scheduled for Thursday, April 9, 2020 at 3:00pm will now be conducted virtually via Zoom. The Department will consider all written comments on this Waterways Application received by Wednesday, April 29, 2020 (Public Comments Deadline). Failure of any aggrieved person or group of ten citizens or more to submit written comments to the Waterways Regulation Program by the Public Comments Deadline will result in the waiver of any right to an adjudicatory hearing in accordance with 310 CMR 9.13(4)(c). The group of citizens must include no less than five citizens who are residents of the municipality in which the proposed project is located.
