Proposed Supplemental FY 2023 Budget. As a result of higher new growth and State Aid, the Mayor is recommending a supplemental appropriation for the Fiscal Year 2023 in the amount of \$2,779,044.00. The mayor is requesting that the sum of \$300,000.00 be placed in the school operation stabilization fund, \$976,000 into the wage stabilization fund, \$1,317,044 placed into the general reserve line item 98035-7800 to cover unforeseen or unanticipated expenses, \$156,000 into DPW personnel line 44004-1000, and \$30,000 for an IT assessment into line item 11255-3000.
