Sisson Elementary School, located at 58 Conomo Avenue, Lynn, Massachusetts, including the payment of all costs incidental or related thereto, and for which a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction the School Building Committee. The City of Lynn, acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the City of Lynn incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the City of Lynn. Further ordered that His Honor the Mayor is hereby authorized to execute a Feasibility Study/Schematic Design Study Agreement Between the City of Lynn and the Massachusetts School Building Authority and all other necessary documents relating thereto for a possible window/door replacement at the Edward A. Sisson Elementary School. The City of Lynn has previously been invited into the Accelerated Repair Program for said possible window/door replacement.
